Staff Report

Because the Crescent Avenue applications are from a husband and wife, the Committee thought one of the parties could be a member and the other is welcome to attend the PC meetings and offer their comments as all the meetings are open to the public. Easter- Carol Ogier's granddaughter, Winnie, has agreed to be the Easter Bunny again this year. Any treats to be passed out will be individually wrapped. The date to stuff the Easter eggs was set for March 28 at 9:00 a.m. in City Hall.

Family Fun Day – Cindy requested the PC members access the Jolly Jumps' website and look at the inflatables available and be ready to discuss at the April meeting.

Upper Limits has not responded to our request regarding a climbing wall. Cindy was going to contact them again.

New/Other Events – Because the January chili cook-off/bingo event was such a success, the Committee wants to have another one in 2021.

The Committee is considering having a wine tasting event possibly in September or October. Cindy knows someone who conducts them and said she will check on what it entails and how much it would cost.
