<u>Water Play Day</u> – The Committee decided to wait on making plans for this event until they knew more about possible St. Louis County restrictions on large gatherings this summer.

<u>Family Fun Day</u> — Cindy reported the rock climbing wall contract had been reviewed and approved. She said the contract for Eurobungy was reviewed by the City attorney and he is suggesting a change in the contract before signing.

<u>Winter Lighting Event</u> – The Committee would like to have carolers again this year but decided to wait on securing them.
