### Agenda

1. Call the meeting to order
2. Roll Call
3. Approval of Agenda
  - a. Janet made a motion to approve the agenda, Doug seconded.
4. Approval of April 14, 2022 minutes
  - a. Doug made a motion to approve the minutes, Janet seconded.
5. Staff Reports
  - a. John reported the basketball backboards have come in but need to be stripped.
  - b. The board approved the purchase of the new split rail fencing
6. Events
  - a. Easter egg hunt – It was a success except we need to ensure the only golden eggs hidden are those with a note saying you are the winner of a prize.
  - b. July concert and fireworks – Because of a mix-up in the date for the fireworks, the Board has decided go forward with the concert featuring Laytham and Holmes from 6:30 – 9:00 p.m. on July 2 and have the fireworks on July 3. The city clerk confirmed the church would be okay with the fireworks on Sunday the 3<sup>rd</sup> as long as no one set up their chairs on their property until 1:00 or later. The Board requested the PC check into the availability and cost of having a food truck on July 2<sup>nd</sup> and an ice cream truck on July 3<sup>rd</sup>. The committee was also asked to find a band or DJ for July 3<sup>rd</sup> prior to the fireworks.
  - c. The PC is still looking for a band for the August 20<sup>th</sup> concert in the park.
  - d. The committee plans to start the planning for Family Fun Day at their June meeting.
7. Park Projects and Improvements
  - a. The City Clerk asked the committee to consider any new park projects or improvements to the park they would like the Board to consider. There were a few suggestions such as upgrading the pickleball court, adding or moving a trash can near the Autumn Leaf gate and adding pavers in the dirt area as you enter the Autumn Leaf gate. The general consensus of the PC members present was it was more important to make needed repairs to the park rather than add a new feature.
  - b. Doug briefed the committee on his presentation to the Board on the possible installation of story boards. He said the Board would like additional information on the cost and installation of the boards but generally liked the idea. Doug was in the process of trying

to obtain information from Grand Glaize Library regarding a possible grant. It was also brought up that Longview Farms Park had taken down their story boards. Doug was going to contact them to determine why.

8. Other Business

- a. Cindy Cornelius submitted an application to join the park committee. Her application was to be presented to the Board at their next meeting.
