AN ORDINANCE ESTABLISHING THE ANNUAL RATE OF TAX LEVY FOR THE YEAR 2016 ON ALL REAL PROPERTY WITHIN THE VILLAGE OF TWIN OAKS, MISSOURI: PROVIDING FOR THE EXTENSION OF SAID TAXES ON THE BOOKS OF THE COLLECTOR OF REVENUE AND PROVIDING FOR THE COLLECTION THEREOF BY THE COLLECTOR FOR THE VILLAGE OF TWIN OAKS, MISSOURI:

BE IT ORDAINED by the Board of Trustees of the Village of Twin Oaks, St. Louis County, Missouri, as follows:

Section I. There is hereby levied on all Residential Real Property and all Personal Property within the corporate limits of the Village of Twin Oaks, Missouri, a tax rate of \$0.0000 per One Hundred Dollars (\$100.00) assessed valuation as shown on the assessment books of the Saint Louis County Assessor, as corrected and amended by the Board of Equalization and certified by the County Clerk, for the calendar year 2016 and there is hereby levied on all Commercial Real Property within the corporate limits of the Village of Twin Oaks, Missouri, a tax rate of \$0.3120 per One Hundred Dollars (\$100.00) assessed valuation as shown on the assessment books of the Saint Louis County Assessor, as corrected and amended by the Board of Equalization and certified by the County Clerk, for the calendar year 2016.

<u>Section II.</u> The Clerk of Saint Louis County, Missouri, and the Revenue Department thereof, are hereby authorized to extend on the books of the Collector the amount of the taxes due and collectible according to the above rates on all Residential and Commercial Real Property and Personal Property within the corporate limits of the Village of Twin Oaks, Missouri.

Section III. The Collector for the Village of Twin Oaks is directed to obtain from the County Clerk of Saint Louis County, Missouri, the necessary Real Estate, Commercial and Personal Property tax abstracts for the purpose of extension, billing and collecting said extended taxes at his office, and the collection of all taxes so extended shall be enforced in the same manner and under the same rules and regulations as may be provided by law for collecting and enforcing the payment of State and County taxes.

<u>Section IV</u>. This Ordinance shall be in full force and effect from and after its passage as by law provided.
