A RESOLUTION OF THE TWIN OAKS BOARD OF ALDERMEN OPTING OUT OF THE AMEREN CLASS ACTION SETTLEMENT

WHEREAS, the City of Twin Oaks has received a *Notice of Class Action Settlement* (the "Notice") in a case styled *City of Winchester, Missouri, et al. v. Union Electric Company d/b/a Ameren Missouri*, 11SL-CC04561, in the Circuit Court St. Louis County, in which the plaintiff cities of Winchester and Creve Coeur allege underpayment of certain business license taxes and fees; and

WHEREAS, a settlement has now been reached and has been preliminarily approved by the circuit court; and

WHEREAS, the Notice asks the recipients to decide whether to remain in the class and agree to the settlement, or whether to "opt out" of the class; and

WHEREAS, although it received the Notice, it is not clear whether the City of Twin Oaks is a member of the class; and

WHEREAS, the Notice states that the City is estimated to receive zero dollars (\$0.00) from the settlement; and

WHEREAS, rather than grant a release to Ameren for unknown claims in an action in which Twin Oaks is not clearly included in the class, the Board desires to authorize the City Administrator to expressly opt out of the class action settlement;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF TWIN OAKS, MISSOURI, AS FOLLOWS:

<u>Section 1.</u> To the extent the City of Twin Oaks is considered a member of the class, the Board of Aldermen hereby opts out of the class and authorizes the City Administrator to execute and send in the **Request for Exclusion** from the class action (Exhibit 1, attached) prior to October 16, 2017.

Section 2. This Resolution is adopted and shall be in full force and effect on and after its passage and approval.
