## CRESCENT ROAD LANDSCAPING PLAN-MERIDITH PERKINS

Mayor Fortune welcomed Meridith Perkins of Davey Resource Group. Mayor Fortune stated that preliminary clearing has been done on Crescent Road. Ms. Perkins stated that there are three goals, she feels, need to be met with this area: 1) Public Safety which we feel has been addressed 2) Maintenance and minimizing long term maintenance and 3) approve the aesthetics of the area.

Ms. Perkins gave a presentation on what she feels would work well in the area. The plants that Ms. Perkins presented would provide a noise buffer for the condos as well as beautify that area. Also, these plants will help to keep the honeysuckle at bay. She also stated that the Condominium Association may want to consider planting within the condominium property, inside the fence, which will add to the noise cancellation. Ms. Perkins stated that other plants can be added as an understory in the future. Ms. Perkins recommended two types of evergreens as well as dogwood and redbud trees. Discussion ensued.
